

Taste of Augusta 2025 CONTEST RULES

These rules apply to **Taste of Augusta** Contest (“Contest”) conducted by Beasley Media Group, LLC d/b/a augustatoday.com. **In addition, the General Contest Rules attached hereto and posted at augustatoday.com website apply to this Contest. If there is a conflict between the General Contest Rules and the Rules for this Contest, the Rules for this Contest shall control.**

All entries must be received by June 16, 2025 at 12:00am ET. Participants can cast their vote once per day.

2. ELIGIBILITY RESTRICTIONS

- a. This Contest is open to all Station listeners who are 21 years of age or older as of the date of entry into the Contest, who are legal US residents and reside in who are legal US residents and reside in Columbia, Richmond, Burke, McDuffie, Glascock, Hancock, Jefferson, Jenkins, Taliaferro, Warren, Washington, Wilkes, and Lincoln Counties, GA and Aiken, Allendale, Barnwell, McCormick, and Edgefield Counties, SC, except where prohibited by law. Winners must possess a valid, government-issued ID and show proof of residency to verify eligibility.
